

Construction Notice

Utility Relocations on 87 Avenue between 175 and 182 Street

UPDATE – May 3, 2022 – On or around May 10, the westbound lane between 175 Street and 182 Street will be reduced to a single lane of traffic. Eastbound traffic will maintain two lanes of traffic.

This lane reduction is expected to last for three days.

Starting on or around April 25, 2022, Marigold crews will work to relocate the sewer line on 87 Avenue to accommodate the construction of an elevated guideway pier.

To accommodate this work, sections of traffic on 87 Avenue between 175 and 182 Street will shift away from construction. Marigold aims to maintain two lanes of traffic in either direction on 87 Avenue with existing left and right turns, however, motorists can expect some lane restrictions. Pedestrians can expect detours.

Most work will occur during daytime hours (7 a.m. – 9 p.m. Monday - Saturday, 9 a.m. – 7 p.m. Sundays); however, some overnight work will be required. Marigold will make every effort to limit work that causes noise and vibrations to daytime hours.

Lane restrictions will occur during peak, off-peak, and overnight hours and are expected to last six weeks.


To accommodate this work, the public will be impacted in the following areas:

- There will be increased construction traffic to the worksite.
- Work will primarily occur during the day (7 a.m. - 9 p.m.). Occasional overnight work may be necessary.
- Traffic lanes of 87 Avenue between 175 and 182 Street will shift away from construction while work occurs.
- Two lanes of traffic in either direction will be maintained. Some lane restrictions can be expected.
- There will be noise associated with this work, particularly when the pavement is removed to access the sewer line. Marigold will make every effort to complete the most disruptive work during daytime hours (7 a.m. – 9 p.m. Monday - Saturday, 9 a.m. – 7 p.m. Sundays).
- There may be vibration associated with this work.
- Marigold will monitor noise and vibration and put mitigation measures in place.
- Area residents can expect dust. Dust mitigation measures will be in place.
- Pedestrian access will be maintained, please watch for detours.

- Access to ETS bus stops may shift in some areas. Please visit <https://www.edmonton.ca/ets/detours-bus-stop-closures> for all ETS changes and update.
- This work is expected to last six weeks.
- Marigold is aware of the residences in the area and will reduce disturbances as best as possible.

We thank you for your patience and understanding during the construction of the Valley Line West LRT project.
