## **Construction Notice**

# Temporary Lane Closures on 104 Avenue Between 112 Street and 116 Street Area 2

On or around **June 26, 2023,** Marigold Infrastructure Partners will begin work to widen 104 Avenue between 112 Street and 116 Street to accommodate upcoming drainage activities.

This work will be performed in two phases. To accommodate this, traffic on 104 Avenue between 112 Street and 116 Street will be shifted away from the work site and one westbound lane will be closed during off-peak daytime and overnight hours (9 a.m. to 3 p.m. and 9 p.m. to 6 a.m.) Work areas will be secured and re-opened at the end of each shift.

Access to Unity Square will be maintained; however, restrictions will be in place. Motorists can expect short-term traffic interruptions to/from Unity Square at 114 Street.

During Phase One, left turns (eastbound to northbound) from 104 Avenue at 114 Street will be banned.

Please follow directional signage in the area.

Pedestrian access will be maintained; however, detours may be implemented. Please follow project wayfinding signage.

Construction will occur during off-peak daytime and overnight hours (9 a.m. to 3 p.m. and 9 p.m. to 6 a.m.) Work areas will be secured and re-opened at the end of each shift.

This work is expected to last three weeks.

Marigold Infrastructure Partners is committed to following all City of Edmonton bylaws and regulations and will obtain an overnight roadwork permit so that work can take place during nighttime hours to minimize major daytime traffic disruptions. \*City of Edmonton Bylaw C14600.

We ask for your understanding and patience as construction progresses.

#### North Side of 104 Avenue between 112 Street and 116 Street - Phase One



#### To accommodate this work, the public will be impacted in the following areas:

#### **Drivers:**

- The outside westbound lane on 104 Avenue between 116 Street and 114 Street will be closed off-peak daytime and overnight hours (9 a.m. to 3 p.m. and 9 p.m. to 6 a.m.).
- Work areas will be secured and re-opened at the end of each shift.
- Left turns (eastbound to northbound) on 104 Avenue at 114 Street will be banned.
- There will be short-term traffic interruptions to/from 104 Avenue at 114 Street.

#### **Pedestrians:**

- Pedestrian access will be maintained on the south side of 104 Avenue between 116 Street and 114 Street.
- Detours will be in place. Please follow project wayfinding signage.

#### North Side of 104 Avenue between 112 Street and 116 Street - Phase Two



#### To accommodate this work, the public will be impacted in the following areas:

#### **Drivers:**

- The outside westbound lane on 104 Avenue between near 114 Street will be closed during off-peak daytime and overnight hours (9 a.m. to 3 p.m. and 9 p.m. to 6 a.m.).
- Work areas will be secured and re-opened at the end of each shift.

#### **Pedestrians:**

- Pedestrian access will be maintained on the south side of 104 Avenue between 116 Street and 114 Street.
- Detours will be in place. Please follow project wayfinding signage.

#### Other impacts for all phases:

- Construction work will occur during off-peak daytime and overnight hours (9 a.m. to 3 p.m. and 9 p.m. to 6 a.m.).
- There will be noise associated with this work. Every effort will be made to reduce the impact to the public.
- This work is expected to last two weeks (approximately one week for each phase).
