

Construction Notice: Valley Line West LRT

Overnight Work on 87 Avenue between 169 & 161 Streets for Elevated Guideway Construction

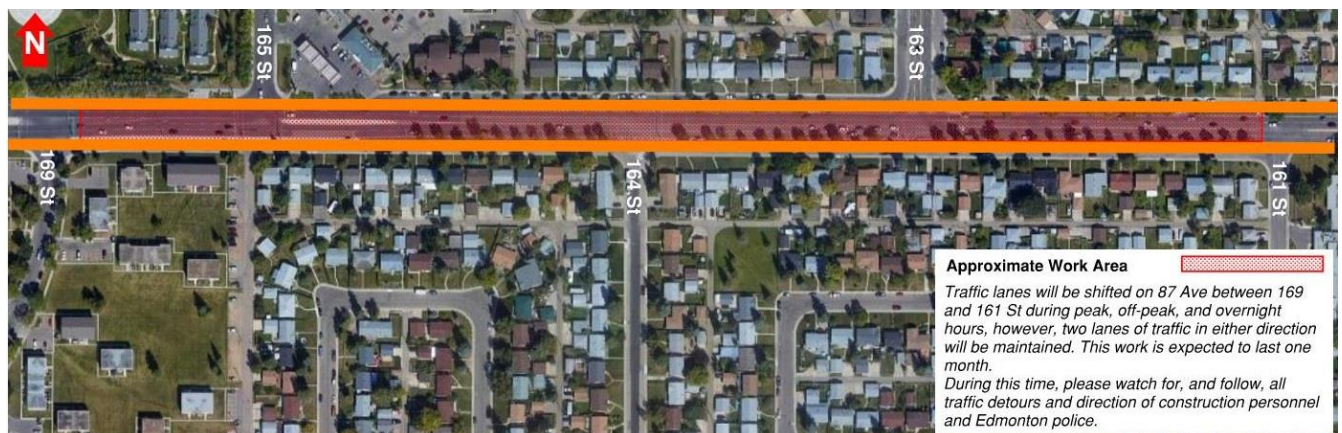
This is a supplemental area notice for work previously mentioned in the following notice: [87 Ave Widening UPDATE](#)

On or around January 21, 2022, Marigold crews will begin overnight utility relocation ahead of construction of the elevated guideway on 87 Avenue. Between 169 Street and 161 Street, crews will be removing duct banks (an underground container used for laying utility lines such as electric and telecommunication cables) and relocating an existing water line to create a work site for pier drilling activities.

To accommodate this work, traffic will be shifted to the outermost lanes to allow work to occur in the middle of 87 Avenue. Two lanes of traffic in either direction will be maintained during this work. Lane shifts will occur during peak, off-peak, and overnight hours and are expected to last one month.

Utility removals and relocations will occur during overnight hours (7 p.m. to 6 a.m.) and is expected to last approximately one month. Marigold will make every effort to limit work that causes noise and vibrations to occur during daytime hours.

87 Avenue between 169 Street and 161 Street



To accommodate this work, the public will be impacted in the following areas:

- Traffic lanes on 87 Avenue between 169 Street and 161 Street will be shifted to the outermost lanes.
- Two lanes of westbound traffic will be maintained.
- Two lanes of eastbound traffic will be maintained.
- Duct bank removals and water line relocation will occur during overnight hours (7 p.m. to 6 a.m.).
- There will be noise associated with this work such as that of work vehicles and tools.
- Every effort will be made to limit work that causes noise and vibrations to occur during daytime hours.
- Pedestrian access will be maintained, however, there will be detours in place.
- Access to ETS Bus Stops will be maintained, however, stops may be shifted slightly. Please visit <https://www.edmonton.ca/ets/detours-bus-stop-closures> for all ETS changes and update.

Marigold Infrastructure Partners is committed to following all City of Edmonton bylaws and regulations and has obtained an overnight roadwork permit so that work can take place during nighttime hours to minimize major daytime traffic disruptions. *City of Edmonton Bylaw C14600.

We ask for your understanding and patience as construction progresses.

The information in this bulletin is current to January 12, 2021. Please note that all dates are approximate and weather dependent. We thank you for your patience and understanding during the construction of the Valley Line West LRT project.
