Construction Notice

Lane Shift on Meadowlark Road/156 Street Between 88A Avenue and 95 Avenue Area 5

On or around **April 3, 2024**, Marigold Infrastructure Partners will resume work on the east side of Meadowlark Road/156 Street between 88A Avenue and 95 Avenue.

To accommodate this, traffic on Meadowlark Road/156 Street between 88A Avenue and 95 Avenue will be shifted west and a single lane in either direction will be maintained. Access to/from the east side of 156 Street will be closed at 89 Avenue (Meadowlark Mall Entrance), 156 Street (by the firehall), 92A Avenue, and 93A Avenue. Access to businesses at 93A Avenue will be maintained from the alley east of 156 Street on 95 Avenue.

Intermittent access closures to/from the west side of Meadowlark Road/156 Street between 88A Avenue and 95 Avenue from cross streets and alleys can be expected. Only one access will be closed at a time.

Pedestrian access will be maintained on the west side of Meadowlark Road/156 Street. Access across Meadowlark Road/156 Street will be maintained; however, detours will be in place. Please follow project wayfinding signage in the area.

Construction will occur during the day (7 a.m. to 9 p.m. Monday through Saturday and 9 a.m. to 7 p.m. Sunday). This work is expected to last until Fall 2024.

To accommodate this work, the public will be impacted in the following areas:

Drivers:

- Traffic on Meadowlark Road/156 Street between 88A Avenue and 95 Avenue will be shifted west away from the work zone.
- Access to/from the east side of 156 Street will be closed at 89 Avenue (Meadowlark Mall Entrance).
- Access to/from the east side of 156 Street will be closed at 156 Street (by the firehall).
- Access to/from the east side of 156 Street will be closed at 92A Avenue.
- Access to/from the east side of 156 Street will be closed at 93A Avenue.
- A single lane in either direction will be maintained.
- Intermittent access closures to/from the west side of Meadowlark Road/156 Street between 88A Avenue and 92 Avenue from cross streets and alleys can be expected.
- Southbound to eastbound left turns at 91 Avenue will be banned.

Pedestrians:

- Pedestrian access will be maintained on the west side of Meadowlark Road/156 Street.
- Access across Meadowlark Road/156 Street will be maintained. Please follow project wayfinding signage.

Other impacts:

- Construction work will occur during daytime hours (7 a.m. to 9 p.m. Monday through Saturday and 9 a.m. to 7 p.m. Sunday).
- Access to Meadowlark Mall will be maintained from other mall entrances.
- Accesses to businesses at 93A Avenue will be maintained from the alley east of 156 Street on 95 Avenue.
- There will be noise associated with this work. Every effort will be made to reduce the impact to the public.
- This work is expected to last until Fall 2024.
