# Preparatory Works Near 107 Street between 102 Avenue and 104 Avenue Area 1

On or around **January 8, 2024**, Marigold Infrastructure Partners will begin preparing the area near 107 Street between 102 Avenue and 104 Avenue for upcoming drainage and roadwork activities. This will include the installation of temporary streetlights and traffic signals, the removal of concrete sidewalks and medians, and temporarily repaving the area. Once this work is complete, drainage work will begin.

This work will be performed during daytime hours (7 a.m. – 9 p.m. Monday – Saturday, 9 a.m. – 7 p.m. Sundays), however, the traffic pattern will remain in place until the work is complete.

- 1. Southeast corner of 104 Avenue and 107 Street eastbound lane closure.
- 2. Northeast and northwest corner of 104 Avenue and 107 Street westbound lane closure.
- 3. Southeast corner of 107 Street and 104 Avenue northbound lane closure.
- 4. Northeast and northwest corner of 103 Avenue and 107 Street westbound lane closure.
- 5. Northeast and southeast corner of 107 Street and 103 Avenue northbound lane closure.
- 6. Northwest and southwest corner of 107 Street and 103 Avenue southbound lane closure.
- 7. Southwest and southeast corner of 103 Avenue and 107 Street eastbound lane closure.
- 8. Northwest and southwest corner of 107 Street and 102 Avenue southbound lane closure.
- 9. Northeast and southeast corner of 107 Street and 102 Avenue northbound and eastbound lane closure.
- 10. Southwest corner of 102 Avenue and 107 Street eastbound lane closure.
- 11. Southeast corner of 102 Avenue and 107 Street eastbound lane closure.

To accommodate this, traffic will be shifted away from the work sites and reduced to a single lane. Pedestrian access will be maintained; however, detours will be implemented. Please follow project wayfinding signage.

This work is expected to last one month.

## To accommodate this work, the public will be impacted in the following areas:

#### **Drivers:**

- Traffic near 107 Street between 102 Avenue and 104 Avenue will be temporarily shifted away from the work zone.
- Motorists can expect single lane closures near work zones.
- Turn movements will be maintained.

#### **Pedestrians:**

• Pedestrian access will be maintained; however, detours will be in place. Please follow project wayfinding signage.

## Other impacts for all phases:

- Construction work will occur during daytime hours (7 a.m. 9 p.m. Monday Saturday, 9 a.m. 7 p.m. Sunday); however, the traffic pattern will remain in place until the work is complete.
- There will be noise associated with this work. Every effort will be made to reduce the impact to the public.
