### **Construction Notice**

## Drainage Works and Span Installation on 87 Avenue near 165 Street AREA 6

On or around **April 22, 2024**, Marigold crews will begin preparing the area on 87 Avenue near 165 Street for the installation of elevated guideway segments.

This work will be performed in two phases. To accommodate this work, traffic on 87 Avenue between 163 Street and 169 Street will be shifted south and a single lane of traffic in either direction will be maintained.

# The elevated guideway spans are expected to be installed over 165 Street on May 18 to June 4. To accommodate this, access to/from 87 Avenue at 165 Street will be closed.

Pedestrian access will be maintained; however, detours will be in place. Please follow project wayfinding signage in the area.

This work will occur during daytime hours (7 a.m. – 9 p.m. Monday – Saturday, 9 a.m. – 7 p.m. Sundays), and is expected to last approximately three months.

- Phase One (April 8 to May 17 approximately) Traffic shift and eastbound/westbound lane reduction on 87 Avenue
- Phase Two (May 18 to June 4 approximately) Temporary closure of 165 Street at 87 Avenue.
- Phase One (June 5 to June 28 approximately) Traffic shift and eastbound/westbound lane reduction on 87 Avenue

## Phase One – 87 Avenue Between 163 Street and 169 Street (April 8 to May 17 approximately, June 5 to June 28 approximately)



#### To accommodate this work, the public will be impacted in the following areas:

#### **Drivers:**

- Traffic on 87 Avenue will be shifted south.
- One lane of traffic in either direction will be maintained.
- Westbound to southbound left turns onto 164 Street will be banned.

#### **Pedestrians:**

- Pedestrian traffic will be maintained; temporary detours will be in place.
- Please observe all project wayfinding signage in the area.

#### Phase Two - 165 Street Access Closure (May 18 to June 4 Only)



#### To accommodate this work, the public will be impacted in the following areas:

#### **Drivers:**

- Access to/from 87 Avenue at 165 Street will be closed.
- Traffic on 87 Avenue will be shifted south.
- One lane of traffic in either direction will be maintained.
- Eastbound to northbound left turns into Petro Canada will be banned.
- Westbound to southbound left turns onto 164 Street will be banned.

#### **Pedestrians:**

- Pedestrian traffic will be maintained; temporary detours will be in place.
- Please observe all project wayfinding signage in the area.

#### Other impacts for all phases:

- Construction will occur during daytime hours (7 a.m. 9 p.m. Monday Saturday, 9 a.m. 7 p.m. Sundays).
- Access to local businesses and residences will be maintained; however, restrictions may be in place.
- There will be noise associated with this work. Every effort will be made to reduce the impact to the public.
