Construction Notice

Lane Closures on Stony Plain Road between 132 Street and 139 Street Area 3

This is a supplemental area notice for work previously mentioned in the following notices: <u>Lane Closure on Stony Plain Road between 129 Street and 132 Street</u>

Beginning **October 27, 2025**, sections of Stony Plain Road between 132 Street and 139 Street will be reduced to a single shared lane during overnight hours (9 p.m. to 6 a.m. Monday through Saturday) to facilitate the installation of Overhead Catenary System poles (OCS - a network of wires suspended above railway tracks to supply electricity to electric trains, which draw power using a pantograph that contacts the overhead wires).

To accommodate this:

- Sections of the eastbound lane or westbound lane on Stony Plain Road between 132 Street and 139 Street will be closed during overnight hours only (9 p.m. to 6 a.m., Monday through Saturday).
- Eastbound and westbound traffic will share a lane.
- Flagging staff will be on hand to maintain traffic.
- While this work takes place, access to/from Stony Plain Road from streets and alleys adjacent to the work will be closed during overnight hours only (9 p.m. to 6 a.m., Monday through Saturday).
- The traffic configuration during these closures will be similar to that shown in the above linked notice (Lane Closures on Stony Plain Road between 129 Street and 132 Street).

Pedestrian access will be maintained; however, detours may be in place. Flagging staff will be on hand to assist pedestrian movements.

This work will occur during overnight hours only and is expected to last two weeks.

Marigold makes every effort to mitigate disruptions, where possible, including but not limited to:

- Incorporating noise mitigation measures for construction activities
- Tailoring noise mitigation to the location and kind of construction activity
- Limiting the size of equipment, where feasible
- Regular equipment inspections and proper mufflers
- Adjusting work methods
- Changing back-up alerts to strobe lights instead of beeping

To accommodate this work, the public will be impacted in the following areas:

Drivers:

- Sections of the eastbound lane or westbound lane on Stony Plain Road between 132 Street and 139 Street will be closed during overnight hours only (9 p.m. to 6 a.m., Monday through Saturday).
- Eastbound and westbound traffic will share a lane.
- Access to/from Stony Plain Road from streets and alleys adjacent to the work will be closed during overnight hours. Please follow area wayfinding signage.
- Flagging staff will be on hand to maintain traffic.
- Drivers can expect traffic delays.

Pedestrians:

- Pedestrian access will be maintained; however, detours will be in place.
- Flagging staff will be on hand to assist pedestrian movements.
- Please follow project wayfinding signage.

Other impacts:

- Work will occur during overnight hours (9 p.m. to 6 a.m., Monday through Saturday).
- There will be noise associated with this work. Every effort will be made to reduce the impact to the public.
- This work is expected to last two weeks.

Marigold Infrastructure Partners is committed to following all City of Edmonton bylaws and regulations and has obtained an overnight roadwork permit so that work can take place during nighttime hours to minimize major daytime traffic disruptions. *City of Edmonton Bylaw C14600.
