## **Construction Notice**

Drainage and Road Works on 87 Avenue between 169 Street and 161 Street (North) Area 6

On or around **July 23, 2025**, Marigold crews will be shifting construction to the north side of 87 Avenue between 169 Street and 161 Street.

To accommodate this, traffic on 87 Avenue between 169 Street and 161 Street will be shifted south and reduced to a single lane in either direction. Pedestrian access will be maintained on the south side of 87 Avenue between 170 Street and 161 Street. Pedestrian access across 87 Avenue.

#### 87 Avenue between 170 Street and 164 Street



#### At 170 Street and 87 Avenue

Full traffic capacities will be maintained at this intersection.

## At 165 Street and 87 Avenue

Access to/from the north side of 87 Avenue from 165 Street will be closed. The east crosswalk across 87 Avenue will be closed.

#### At 164 Street and 87 Avenue

Access to/from the south side of 87 Avenue from 164 Street will reopen to right in/right out traffic.

#### 87 Avenue between 164 Street and 159 Street



#### At 163 Street and 87 Avenue

Traffic on 163 Street near 87 Avenue will be shifted west and reduced to a single lane in either direction near the intersection. Turn movements will be maintained.

#### Between 161 Street and 159 Street

Westbound traffic on 87 Avenue will be shifted north.

#### At 159 Street and 87 Avenue

Full traffic capacities will be maintained at this intersection.

Construction activities will be performed during daytime hours (7 a.m. to 9 p.m. Monday through Saturday and 9 a.m. to 7 p.m. Sunday) and is expected to last three weeks.

To accommodate this work, the public will be impacted in the following areas:

#### **Drivers:**

- Traffic on 87 Avenue between 169 Street and 161 Street will be shifted south.
- One lane in either direction will be maintained between 169 Street and 161
  Street.
- Access to/from 87 Avenue at 165 Street will be closed.
- Access to/from 87 Avenue at 164 Street will reopen to right in/right out.
- Traffic on 163 Street will be shifted west.
- One lane in either direction will be maintained at 161 Street and 87 Avenue.
- Turn movements are maintained, where access permits.
- The intersection of 170 Street and 87 Avenue will remain open at full capacity.
- The intersection 159 Street/Meadowlark Road and 87 Avenue will reopen to full capacity.

#### **Pedestrians:**

- Pedestrian access between 165 Street and 161 Street will be maintained on the south side of 87 Avenue.
- Please follow project wayfinding signage.

## Other impacts:

- Construction will occur during daytime hours (7 a.m. to 9 p.m. Monday through Saturday and 9 a.m. to 7 p.m. Sunday).
- There will be noise associated with this work. Every effort will be made to reduce the impact to the public.
- This work is expected to last three weeks.
