### **Construction Notice**

# Herbicide use along 156 Street from 100 Avenue to 163 Street at 87 Avenue AREA 5 / 6

On or around **July 7, 2025**, weather permitting, Marigold licensed applicators will begin hand spraying the construction areas on both sides along 156 Street from 100 Avenue to 163 Street at 87 Avenue with the herbicide Trillion, to control noxious weeds.

Trillion is effective at combatting noxious weeds and will be sprayed by a licensed applicator. Marigold has obtained a permit for this work and is compliant with all local regulations. Signage will be displayed in the vicinity when spraying. There will be no adverse effects on surrounding plants or pets, as the spray dries within minutes. Strict safety precautions are taken to protect the public, employees and environmental health.

There will be no impacts to vehicular and pedestrian traffic in the area. Please follow all project wayfinding signage in the area.

This work will be occurring during daytime hours (7 a.m. – 9 p.m. Monday – Saturday, 9 a.m. – 7 p.m. Sundays), until the work is complete. This work is expected to take place periodically until September 1, 2025.

To accommodate this work, the public will be impacted in the following areas:


#### **Drivers & Pedestrians:**
