Construction Notice

Preparatory Works on 87 Avenue near 165 Street AREA 6

On or around **April 8, 2024,** Marigold crews will begin work to prepare the area on 87 Avenue near 165 Street for elevated guideway span installation. This includes the installation of temporary streetlights and traffic signals, the removal of concrete sidewalks and medians, and then temporary repaving of the area. Once this work is complete, traffic can be shifted onto the repaved area allowing the guideway span installation to begin.

This work will be performed in three phases. To accommodate this work, traffic on 87 Avenue between 163 Street and 165 Street will be shifted away from the work site and a single lane of traffic in either direction will be maintained.

Pedestrian access will be maintained; however, detours may be in place. Please follow project wayfinding signage in the area.

Construction will be performed during overnight hours (9 p.m. to 6 a.m.) and is expected to last one week. Each area will be secured and re-opened to vehicle traffic at the end of each shift.

- 1. 87 Avenue east of 165 Street outside eastbound lane closure
- 2. 87 Avenue east of 165 Street inside eastbound lane closure
- 3. 87 Avenue east of 165 Street westbound lane closure

Marigold Infrastructure Partners is committed to following all City of Edmonton bylaws and regulations and will obtain an overnight roadwork permit so that work can take place during nighttime hours to minimize major daytime traffic disruptions. *City of Edmonton Bylaw C14600.

We ask for your understanding and patience as construction progresses.

To accommodate this work, the public will be impacted in the following areas:

Drivers:

- Traffic on 87 Avenue will be shifted away from the worksite during overnight hours (9 p.m. to 6 a.m.).
- One lane of traffic in either direction will be maintained.

Pedestrians:

- Pedestrian traffic will be maintained.
- Please observe all project wayfinding signage in the area.

Other impacts:

- Construction will occur during overnight hours (9 p.m. to 6 a.m.).
- Access to local businesses and residences will be maintained; however, restrictions may be in place.
- There will be noise associated with this work. Every effort will be made to reduce the impact to the public.

- This work is expected to last one week.
